Please read this carefully as it contains important information in relation to the collection, use and disclosure of your personal information that you provide to TEN Group.

You understand that:

 - (b) we will be unable to send you direct marketing communications (unless you have consented to such communications through your other dealings with TEN Group).
5. Your personal information may be disclosed to the following classes of people and organisations in connection with the purposes in paragraph 3:
 - (a) TEN Group, its personnel and related entities;
